## THIS IS TO CERTIFY

That in accordance with the provisions of Paragraph 9 in Annex 1 of the MSC.1/Circ. 1206, our Flag Administration hereby authorizes INDEPENDENT MARINE SURVEYORS GROUP S.R.L. of Chisinau, Republic of Moldova (hereinafter referred to as the Organization) to carry out the annual inspection, servicing and testing of Life Rafts and their Launching Appliances fitted on board the above-mentioned vessel whilst at Chernomorsk, Ukraine.

Conditions under which this authorization is granted:

1. The Organization shall carry out the maintenance, testing, servicing and inspections of vessel's Life Rafts and their Launching Appliances in compliance with the Guidelines for Periodic Servicing and Maintenance of Lifesaving Appliances, Launching Appliances and On-load Release Gear adopted by the International Maritime Organization in MSC.1/Circ.1206 and SOLAS Reg. III/20.11.
2. The Organization attests that they comply with the qualifications and capabilities specified in the Section 4 of our Merchant Shipping Notice MSN-0025.
3. An authorized Surveyor from Russian Maritime Register of Shipping (RMRS) will be in attendance during the inspections and servicing of the Lifeboats and their Launching Appliances.
4. The Organization must also comply with any additional requirements from RMRS.
5. A Certificate of Inspection and Servicing shall be issued by the Organization and a copy submitted to our Administration upon completion of the inspection and servicing of Life Rafts and their Launching Appliances.
6. This is a one-time only authorization; it is not transferable and cannot be used to provide a different service on board this or another vessel at another date and time.

This authorization is granted under the authority of the Government of Belize and will be valid only for the above-described service on board the M/V LAVR.
